- As per modified consent terms filed, Company was required to pay certain amounts to Bank against outstanding. During the quarter the Company has sold a majority of its Assets for reducing its debt. Part of the amounts claimed by Bank were paid from sale of the assets of the Company and Company has not been able to strictly adhere to the payment schedule thereafter. Company is in process of discussions with Bankers to ensure amicable resolution and payment of the agreed amounts. In case the resolution as envisaged is not arrived at, the appointment of provisional liquidator would stand revived.
- Amounts receivable from certain debtors of the Company has not been recovered and the Company has made provision during the quarter as a prudent business practice to present a more accurate picture. The Management is hopeful to recover the amounts.
- During the quarter Board approved the conversion of 12,10,000 Convertible preferential warrants to equity shares, the proceeds of which were utilized for the business needs of the Company.
- The Management is of the opinion and has presented the A/Cs on going concern basis. Even though the assets of the Company have been sold the Company has been able to generate sales by outsourcing its manufacturing requirements. The Management is also in discussions to raise further funds for the business needs of the Company which would have a positive impact on the worth of the Company. As such the bank issue is resolved there should not be any doubt on the status of the Company as a going concern.
